Carbon Neutral Schools

CARBON NEUTRAL SCHOOLS is an ERASMUS Project that aims to develop an online interactive e-learning course and put it freely available to schools, the main focus of the project, HEIs and vocational schools. The aim is to show schools, HEI and vocational schools, what can be done to lower carbon emission, based on practical guidelines that can be taken up without much previous knowledge on the topic and that are based on the experience that pioneer schools in the field have already implemented. The course will be therefore developed in cooperation with schools. The project will also introduce the concept of Green Ambassadors, to support and lead the organizations to the zero carbon goals. The result of the project will be developed as a collection of interactive e-learning modules.

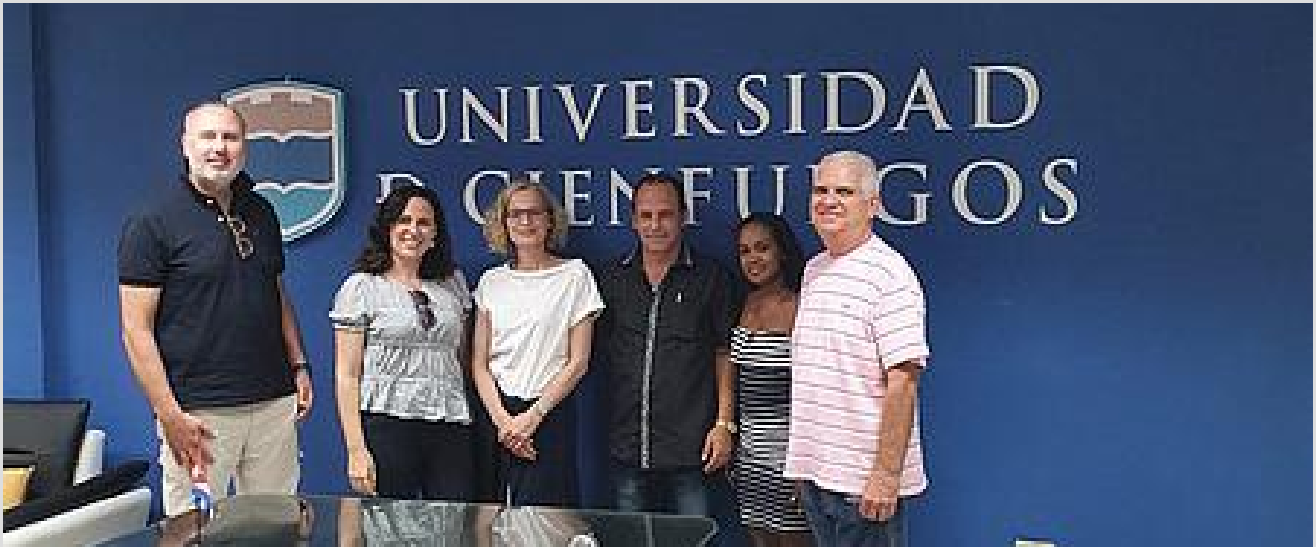


Student Energy Fellowship 2023

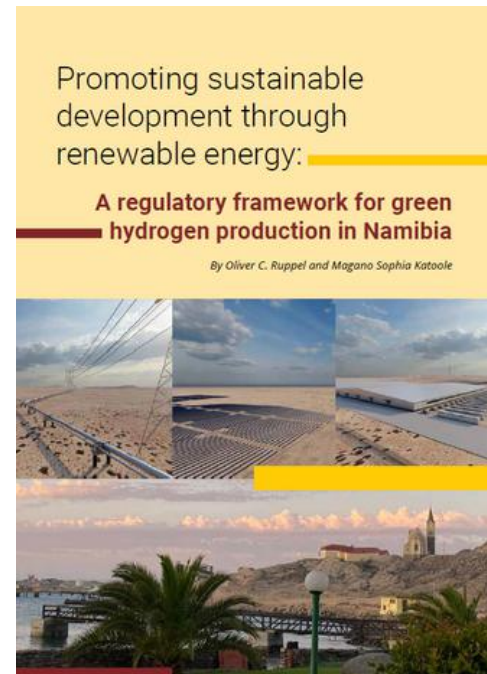

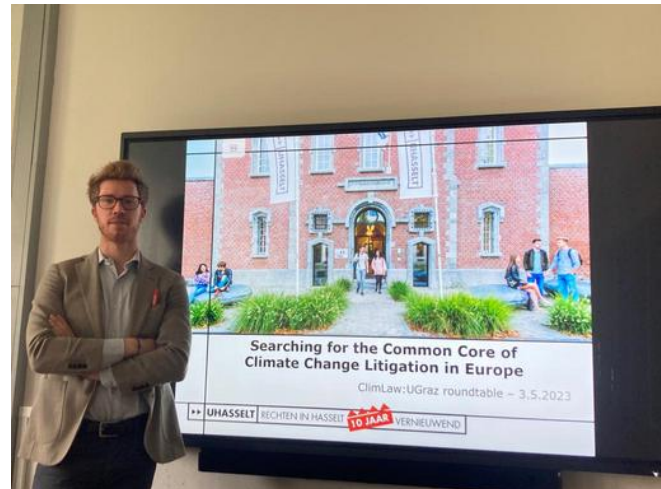

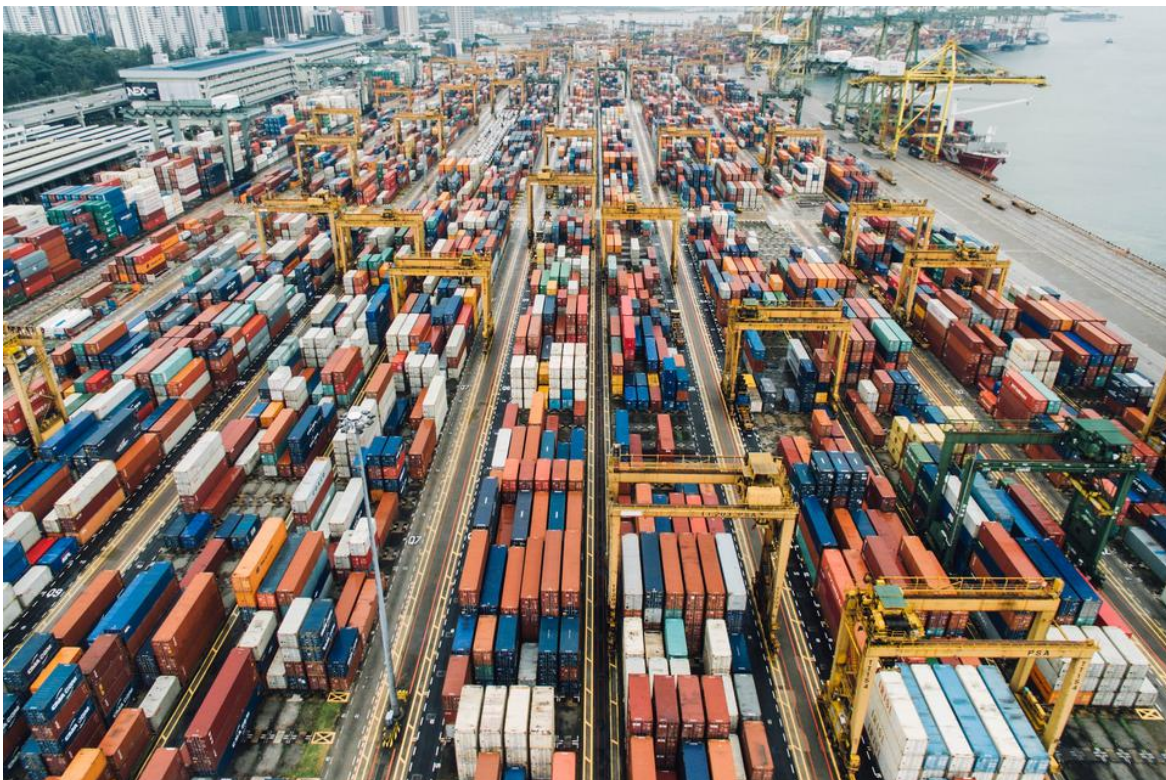

The project assesses existing literature as well as about 80 globally representative Free Trade Agreements, combining the TREND database with a qualitative analysis of their provisions. The workshop presented and discussed the project's preliminary findings and open questions.

During her stay in Graz, Prof. Dr. Dagniselys Toledano presented a number of lectures and presentations at ClimLaw: Graz and the University of Graz.

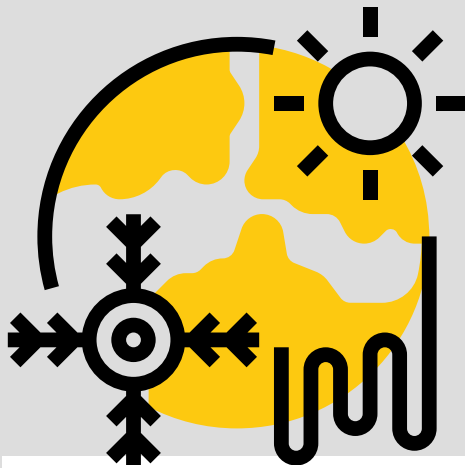

ClimLaw: Graz Director, Prof. Oliver C Ruppel, participated in a panel discussion at the Environmental Policy and Law webinar on "The Triple Planetary Crisis: The Role of Scholars and the Decision-makers".



Background

In an address of June 2, 2022 at the Stockholm+50 Conference, the United Nations (UN) Secretary-General Antonio Guterres warned that we have not kept our promises on the environment since our consumption is “at the rate of 1.7 planets a year” and the “global well-being is in jeopardy”. Inger Andersen, UNEP executive director, also underscored that “If we do not change, the triple planetary crisis of climate change, nature and biodiversity loss, and pollution and waste will only accelerate.” The alarm bells rung by the UN decision-makers have been based upon the findings of several scientific reports in 2022 (including IPCC6; UNEP and WMO). Thus, the gathering storms indicate a planetary-level environmental crisis. Do they cast shadows of the coming events before in the 21st century? Humankind seems to be sleepwalking into an existential ‘triple planetary crisis’ almost akin to some of the catastrophic events that devastated the world in the 20th century.

The African Soil Partnership (AfSP) was established in May 2015, consisting of the Sub-Saharan countries and specialises on regional actions through implementation plans, which are revised at the yearly AfSP plenary meetings. It covers subjects similar of the Global Soil Partnership (GSP) which is a recognized mechanism established in 2012, with the mission to position soils in the Global Agenda through collective action. Such as the promotion of Sustainable Soil Management (SSM) and improvement of soil governance in order to guarantee healthy and productive soils by providing essential ecosystem services towards food security.

Österreichische Umweltrechtstage in Linz

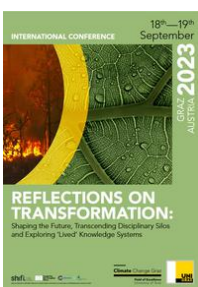

Blogbeitrag für Geplante Aufhebung der IG-L-Geschwindigkeitsbeschränkung („Lufthunderter“) auf der Tauern Autobahn in Salzburg

Nachdem das Bundesland Salzburg bereits im November 2022 die nach dem Immissionsschutzgesetz – Luft (IG-L) verordnete Geschwindigkeitsbeschränkung für eine Teilstrecke der West Autobahn (hier war für den Salzburger Zentralraum ein „Luft-80er“ vorgesehen) aufgehoben hat (LGBl 2022/89), steht jetzt auch der „Lufthunderter“ auf der Tauern Autobahn vor dem Aus. Konkret soll das nach dem IG-L verordnete luftgüteabhängige und damit flexible Tempo-100-Limit auf der A 10 zwischen Salzburg und Golling (LGBl 2015/26 idgF) mit 1. November 2023 aufgehoben werden. So sieht es jedenfalls ein entsprechender Verordnungsentwurf des Landeshauptmannes von Salzburg vor. Begründet wird die Aufhebung damit, dass die Stickstoffdioxid-Grenzwerte auf dem genannten Autobahnabschnitt seit drei Jahren nicht mehr überschritten wurden. Auch sei einer wissenschaftlichen Studie zufolge nicht damit zu rechnen, dass die Grenzwerte in Zukunft überschritten werden, und zwar auch dann nicht, wenn Tempo 130 wieder gilt.
