#### Curriculum for the master's program Political, Economic and Legal Philosophy / Philosophie der Politik, Ökonomie und des Rechts at the University of Graz



The University Act (UG) and the Statute of the University of Graz form the legal framework of the master's program Political, Economic and Legal Philosophy (PELP).

On 22.5.2019, the Senate enacted the following curriculum specified in § 25 para.1 [10] UG for the master's program Political, Economic and Legal Philosophy (PELP).

#### § 1 Subject, qualification profile, and relevance

#### (1) Subject of study

The interdisciplinary master's program Political, Economic and Legal Philosophy / Philosophie der Politik, Ökonomie und des Rechts (PELP) focuses on problems of practical philosophy with regard to the relationship of (normative) theory and (political and economic) practice. This master's program is also offered as a part-time program that can be done concurrently with working.

Investigating social institutions, procedures and social behaviour solely using methods based on political, economic and social sciences would lead to an incomplete and distorted picture of diverse social phenomena. The reason for this is that such phenomena are interdependent and can only be appropriately interpreted and regulated on the basis of their normative implications. Politics, law and economics are inextricably interwoven. Most economic decisions and considerations have political implications or are based on political deliberations - and all political and legal decisions have economic consequences. The master's program PELP aims to contribute to the investigation of social phenomena by encouraging students to consider conceptual and substantial connections between the disciplines of social, legal and economic sciences in their own, ideally philosophically motivated, research work. In that context, practical philosophy has the following tasks: to investigate the connection between the above-mentioned disciplines and to investigate and test their methodical presumptions; furthermore, to define the principles and criteria of normative evaluation and highlight the normative implications of economic and political-legal behaviour. The master's program PELP aims to support students in their use of methods from political and legal, economic and socio-scientific disciplines in the sense of developing normatively oriented problem-solving strategies. Hence, the master's program PELP is characterised by a strong interdisciplinary and transdisciplinary approach, combining theoretical and applied elements of science and philosophy.

Within the framework of the master's program, a double degree program is offered in co-operation with the Ruhr University Bochum. In this program, students are given the possibility of developing their focus in the field of

#### (2) Qualification profile and competences

The master's program PELP aims to enable students to identify normative implications of public law, economic and political decisions and to analyse the ethical dimensions of governmental, non-governmental and entrepreneurial action. It intends to enable all students to investigate and seek solutions to complex political, economic and legal problems and to normatively develop and assess reform proposals and solutions based on criteria of justice. To that end, students are introduced to the relevant methods of philosophy, legal, economic and social sciences, particularly to ethical argumentation and political decision-making procedures, including their methods of implementation. At the same time, they are also helped and taught to carry out in-depth analysis of basic aspects and problems concerning those sciences on a methodological, theoretical and practice-based level (e.g., the capability of social sciences

to explain and predict, the problems of value neutrality, the relationship between ideal and non-ideal normative theory, and the theory of the second-best).

Graduates of PELP master's program will:

- have a higher level of understanding in some areas of practical philosophy, legal, social and economic sciences and the ability to comprehend and utilise the relevant methods of those disciplines.
- be able to analyse social phenomena and problems from a normative-critical and integrative perspective.
- be able to develop and explain normative oriented problem-solving strategies for complex problems (e.g. reform of social insurance systems, global distribution, climate protection, or improvement of the legitimacy of international decision-making processes).
- be able to utilise the co-operative, integrative and communicative competences acquired during the program in interdisciplinary discourse.
- be able to carry out scientific research independently and at research institutions (research assistant) and collaborate in research projects (research project assistant), particularly as part of interdisciplinary and cross-faculty courses.

Graduates of the Double Degree Program are additionally able to:

- develop and motivate the above-mentioned problem-solving strategies, including for example, the short-term, mid-term and long-term pressing problem complex of global poverty and migration in the context of climate change.
- feel confident in the international field of study and research. Aforesaid competence is established and enhanced through the double degree program's international network, and in particular, through the students' obligatory stay abroad.

#### (3) Necessity and relevance of the study program for scientific research and the labour market

From a scientific point of view, this master's program, which is also offered on a part-time basis, makes a major contribution to the promotion of interdisciplinary research. Tutors and students alike can benefit immensely from this cross-disciplinary master's program with regard to the scientific fields mentioned above. Its special combination of philosophy, social and economic sciences (including law) is highly regarded in academic circles. This interdisciplinary field of academic research has developed over a period of many years. In the Anglo-American world, many influential authors in the field of practical philosophy (especially with regard to political philosophy) hold a socio-scientific (and interdisciplinary) education in great regard. At other universities in Anglo-American and in German-speaking countries where comparable study programs are already established, many of the very best students have opted for such a program of study.

Owing to the acquisition of (specialist, methodical, social and personal) competences as specified in and § 1 (3), the master's program greatly promotes professional qualifications. This master's program is designed to prepare students for their later academic careers as well as for 'practical' activities required in administration, politics, economy and civil society, and to qualify them for the educational sector

as well. There are plenty of good opportunities on the labour market: particularly in state-owned and non-governmental institutions and businesses there is a huge (and presumably increasing) need for well-trained university graduates who are able to develop and assess proposals to reform and solve complex social problems based on academic and normatively critical methods.

Graduates of the master's program could embark on careers in the following sectors:

- Administrative and public sector
- NGOs
- Political parties and associations
- Private businesses
- Consultant jobs (political counselling, consulting and ethical counselling)
- Media (media enterprises or journalism)
- Universities, Universities of Applied Sciences and other educational institutions

Graduates of the double degree program are moreover especially qualified to:

- pursue careers in English speaking countries as English as a teaching language as well as the compulsory stay abroad lead to an improved competence in English and allows students to be experienced in an international environment
- pursue jobs in research and teaching as the research-oriented nature of the program as well as its international orientation leads to improved relevant competences

Graduating from the master program allows graduates to pursue doctoral studies in philosophy at the University of Graz.

#### § 2 General requirements

#### 1) Requirements for admission

(1.1) In order to be admitted to the master's program Political, Economic and Legal Philosophy (PELP)/ Philosophie der Politik, Ökonomie und des Rechts, students should have a bachelor's degree in Philosophy or in a related field of study, in a suitable University of Applied Sciences bachelor's program, or in a different program of equal status at a recognised post-secondary educational institution at home or abroad. In all cases, students presenting evidence of such an advanced level are eligible for admission to university. The Rectorate decides on equivalence according to § 60 para. 1 UG.

(1.2) A bachelor's program or a similar University of Applied Sciences program shall be eligible if the following requirements are fulfilled:

(1.2.1) Specific subject-related, i.e., philosophical courses amounting to a minimum of 30 ECTS credit points must have been completed.

(1.2.2) These subject-specific courses must include at least 6 ECTS credit points from courses on introduction to logic, 5 ECTS credit points in theoretical philosophy, 13 ECTS credit points in practical philosophy and 6 ECTS credit points in history of philosophy.

Programs requiring at least 180 ECTS credit points are equivalent in a relevant program. Complete equivalence can be achieved by additionally doing courses of maximally 30 ECTS credits from the in (1.2.2) listed areas.

As a requirement for admission, sufficient knowledge of English or German is to be shown. The exact form of how that knowledge is to be shown shall be defined by the rectorate.

#### (2) Duration and Structure of the Program

The master's program Political, Economic and Legal Philosophy involves a workload equal to 120 credit points (ECTS), lasts four semesters and has a modular structure. These are allotted as follows:

#### (3) General information on the Double Degree Program PELP

#### Application, selection and admission of the students

Students of the master's program PELP may apply for admission to the double degree program. Students are required to pass a selection procedure for admission to the double degree program. The selection is carried out by a selection committee consisting of at least two teachers of the program from the University of Graz based on the submitted application documents. Qualification criteria specifically include the candidate's preliminary education and personal motivation, their knowledge of English.

Application deadlines are published at least two months before the deadline on the website of the Ruhr University Bochum and on jointdegree.eu. Candidates are selected and notified within four weeks following the application deadline.

#### (4) University Degree

Graduates of the master's program are awarded a Master of Arts degree, abbreviated as MA.

Graduates of de Double Degree program are awarded a degree from both the University of Graz and the Ruhr University Bochum. The awarded degree is awarded jointly by the universities. Graduates do only have the right to list one academic title.

#### (5) Restricted admission to courses and ranking system

a. For pedagogical and didactical reasons, or for safety reasons, the number of participants is limited in some types of course:

b. If the upper limit of participants is reached, admission to courses will be decided on the basis of guidelines of the senate.

#### (1) Modules and courses

In the following, examination subjects are named according to their course title, course type, ECTS credit points, contact hours (con/hrs) and their recommended allocation to a semester (rec. sem.). The column "RQ/REC/FE" indicates whether a required course/compulsory subject (RQ), a restricted elective course (REC) or free elective (FE) is referred to. Students should choose from restricted elective courses according to the requirements. The modules are described in Appendix 1

#### (2) Master's thesis

- (3.1) General Information
- a. The subject of the master's thesis should be derived from the following subjects or should be related meaningfully to one of them:
  - Political philosophy
  - Legal philosophy,
  - Ethics and moral philosophy,
  - Social philosophy,
  - Philosophy of legal and social sciences
- b. It is recommended that students choose the topic of the master thesis in the third semester and start writing in the third semester. It is recommended that the fourth semester is mostly used to complete the master thesis.

(3.2) Should the study program be carried out as a double degree program, the following rules shall apply:

- a. The master's thesis must be written at University of Graz.
- b. The master's thesis must be written in English.
- c. Two supervisors, i.e. a supervisor and co-supervisor, are required for the master's thesis; the supervisor shall be provided by the University of Graz and the co-supervisor by the partner university.
- d. Students should endeavour to seek a suitable subject during their study abroad, i.e. in their third semester, as a rule, and reflect on that subject as part of their selected double degree research emphasis.
- e. During their stay at the partner university, they are required to complete work on the master's thesis amounting to 11 ECTS. The co-supervisor is required to confirm that the work has been done.

#### (3) Free electives

It is recommended to select free electives from the following areas:

- Women's studies and gender research
- Support offered to those entering the world of employment (basic information about labour and social legislation, application and communication training)
- Education, media and culture (e.g. cultural studies, culture management)
- Economics and Management
- Methodological aspects of multi-, trans- and interdisciplinarity
- Assessing the consequences of science and technology
- Ethics in medicine, technology and economics
- Politics
- Law
- Religion
- Human rights and education in human rights
- Research on peace and conflict
- Global studies

- Social competence (in particular, see courses offered by the Centre for Social Competence)
- Communication and information technology
- Foreign languages
- Courses from special research areas, university centres and university courses
- Courses from other philosophical departments and philosophy-related departments (e.g. Department of Legal Philosophy, sociology of law and legal informatics at the Faculty of Law, Department of Philosophy at the Faculty of Catholic Theology, Department of Musical Criticism at the University of Music and Performing Arts, Graz).

#### (4) Studying abroad and practical experience

a. Recommended studies abroad

Students are recommended to do a semester abroad during their master's program. The third semester is particularly suitable for that purpose.

b. Students of the double degree program PELP are obliged to complete one semester abroad at one of the partner universities of that double degree program amounting to a minimum of 30 ECTS credit points. During their study period at the partner university, students must participate in the modules specified in § 3 (1.2) or § 3 (1.3) in prior agreement with their co-supervisor at that particular university. A compulsory stay at the relevant partner university is recommended during the third semester. Students selected for the double degree program can register to stay at the relevant partner university by 31<sup>st</sup> August for both of the following semesters. In order to graduate from the double degree program, students must have delivered positive achievements worth a minimum of 30 ECTS credit points at the Ruhr University Bochum according to § 3 (1.2).

#### §4 Forms of teaching and learning

#### (1) Part-Time Studying

PELP can be studied part time. Part-time studies will be organized differently to full-time studies, so as to allow the combination of working and studying.

#### (2) Teaching language

The teaching language in the master's program PELP may be German or English depending on the teacher's preference. Courses are offered to ensure that the master's program can be completed entirely in German.

In the double degree program, only courses held in English will count. Equally, all examinations that are part of the Double Degree Program, except for the free electives, must be taken in English.

# § 5 Examination regulations

#### (1) Master examination

The master examination is taken orally before an examination board and is worth 6 ECTS credit points.

The examination board consists of three people.

The master examination involves the following: (a) defence/presentation of the master's thesis (20 minutes) (b) subject area relating to the master's thesis (30 minutes) (c) one of the following subjects that differs from the subject of the master's thesis:

- Political philosophy
- Legal philosophy,
- Ethics and moral philosophy,
- Social philosophy,
- Philosophy of science of legal and social sciences

The master examination can only be taken if the candidate has completed all courses positively and their master's thesis was positively assessed.

If the examination is taken as part of the double degree program at the University of Graz as the candidate's original university, the co-supervisor of the master's thesis from the relevant partner university is not required to take part, but may take part in the examination if he or she so wishes.

## § 6 When the curriculum becomes effective

(1) This curriculum became effective on 1st October 2010. (2010 Curriculum)

(2) Amendment of this curriculum as announced in the University Gazette of 22<sup>nd</sup> June 2011, 38<sup>th</sup> year, issue 94, became effective on 1<sup>st</sup> October 2011 (2011 version of the 2010 curriculum).

(3) The amendment of this curriculum as announced in the University Gazette of [21/12/2016, [12.c] issue, [14] special issue, will become effective on 1<sup>st</sup> October 2017 (2017 version of the 2010 curriculum).

(4) The 3. Amendment of this curriculum as announced in the University Gazette of 22<sup>nd</sup> May 2019, 31<sup>st</sup> year, issue 103, became effective on 1<sup>st</sup> October 2019. (2019 version of the 2010 curriculum)

## § 7 Transitional Regulations

(1) Students of the master's program PELP who are subject to the 2010 version of the curriculum when the amendment of the curriculum became effective on 1<sup>st</sup> October 2011 are subject to the 2011 version of the curriculum as of 1<sup>st</sup> October 2011.

(2) Students of the master's program PELP who are subject to the 2011 version of the curriculum when the amendment of the curriculum becomes effective on 1<sup>st</sup> October 2017 shall be subject to the 2017 version of the curriculum as of 1<sup>st</sup> October 2017.

(3) Students of the master's program PELP who are subject to the 2017 version of the curriculum when the amendment of the curriculum becomes effective on 1<sup>st</sup> October 2019 shall be subject to the 2019 version of the curriculum as of 1<sup>st</sup> October 2019.

Please note that § 78 para. 5 UG shall apply for the recognition of examinations during study periods abroad (advance letter).

b. Recommended practical experience Students are recommended to complete a four-week full time career-oriented internship as part of their free elective subjects (amounting to 6 ECTS credit points). One week's full time internship would therefore correspond to 1.5 ECTS credit points. Active participation in an academic course also counts as practical experience. This form of practical experience must be authorised by the organ responsible for matters pertaining to the Study Act and it should have a meaningful connection to the study program in question.
