

## 14<sup>th</sup> EIASM Workshop on Accounting and Economics in Rotterdam

Erasmus School of Economics in Rotterdam hosted the 14th EIASM Workshop on Accounting and Economics on July 7th and 8th, 2022. The event, chaired by Eva Labro (University of North Carolina), Jeroen Suijs (Erasmus University Rotterdam), and Alfred Wagenhofer (CAR), brought together leading accounting scholars from around the world to promote the application of economic analysis in accounting research. The conference featured 35 presentations, among them paper presentations by DART students and alumni Daniel Fabisch, Anna Kasmanhuber, Viktoria Kern, Martin Klösch, Reinhard Schrank, and Theresa Wittreich. They received valuable feedback and profited greatly from comments and questions by their respective discussants and the general audience. The conference attracts more than 400 participants each year from Europe and other parts of the world and provides a platform for delegates and members to present and discuss the latest research in industrial economics. CAR's Michael Kopel presented his recent working papers "Investment Incentives in Multi-Product Distribution Channels" (coauthored by Nicole Johnson, Clemens Lankisch, and Thomas Pfeiffer) and "Managing Investments under Bargaining in A Coopetitive Supply Chain" (coauthored by Cong Pan and Shohei Yoshida). Peter Habiger (Department of Organization and Economics of Institutions) presented "Information acquisition, strategic ignorance, and manufacturer encroachment", joint work with Michael Kopel. The audience provided valuable suggestions and input.
