Audit Firms Cooperate with CAR in Research Projects

In the course of pursuing its mission to contribute to the development of accounting theory and to accounting practice the Center for Accounting Research strives to cooperate with accounting practitioners. In recent months three major Austrian audit firms agreed to provide funding to support research at CAR. While CAR gratefully acknowledges a two-year support from the former KPMG – Bertl und Fattinger audit firm, after their split both firms agreed to continue their support.

BDO Rabel & Pilz, Bertl/Fattinger and KPMG each fund the part-time salary of a recent graduate and now doctoral student to work with CAR. They institutionalize a two-way exchange of ideas by funding young researchers who have a stand in academia and another in a major audit firm. These arrangements serve to transfer knowledge between academic research and practice, as we believe both can learn from each other. We thank these firms for their generosity.

In Austria, KPMG operates nationally across 8 offices employing more than 1,100 people and provides audit, tax and advisory services. KPMG will fund Mag. Rebekka Kager who started out as a research assistant at the Institute of Accounting and Taxation (Professor Niemann) and will work on the intersection between IFRS financial reports and income taxes.



Professor Ralf Ewert accepts position as Chair for Accounting and Auditing

Professor Ralf Ewert from Frankfurt's Goethe University, Germany, has accepted the position of Chair for Accounting and Auditing at the University of Graz. He will also be an integral part of CAR. Ewert's status as an outstanding researcher is documented by numerous journal contributions, editorship of a leading journal, Review of Managerial Science, as well as a recent report on the economic impact of auditor liability regimes that was commissioned by the Directorate General Internal





Market and Service of the European Commission. Professor Ewert is an international leader in quantitative accounting research. His appointment gives CAR a unique position in analytical accounting research not only in the German-speaking countries and puts it on the forefront of international academic accounting research. Alfred Wagenhofer honored
