LARRY SAMUELSON

Larry Samuelson is the A. Douglas Melamed Professor of Economics and director of the Cowles Foundation at Yale University. Larry Samuelson has worked on almost everything from capital theory, history of economic thought, labor economics, industrial organization, to decision theory, game theory, and the evolutionary basis of economic behavior.

He is the author of "The Marginal Product of Capital in an Aggregate Production Function", "Evolutionary Games and Equilibrium Selection", "Repeated Games and Reputations: Long-Run Relationships" (with George Mailath), and most recently, "Analogies and Theories" (with Itzhak Gilboa and David Schmeidler).

Larry Samuelson earned his B.A. in economics and political science, and his M.A. and Ph.D. (1978) in economics at the University of Illinois in Urbana. He held appointments at the University of Florida in Gainesville (1978-1979), Syracuse University (1979-1982), Pennsylvania State University (1982-1990), before he was named the Antoine Augustin Cournot Professor of Economics, and, later, the Hilldale Professor of Economics at the University of Wisconsin in Madison. He joined Yale University in 2007.

He served as coeditor of "Econometrica" (2005-2010), the "American Economic Review" (2010 – 2016), and is coeditor of the "American Economic Review: Insights" since its inception in 2017.
