<b>Application</b>	<p>Nominated students will receive instructions for the online application via email.  The application incl. data entry &amp; uploads have to be completed online!</p> <p><b>Application deadlines:</b>  <b>1<sup>st</sup> June</b> for the winter semester / academic year  <b>1<sup>st</sup> November</b> for the summer semester</p>
<b>Acceptance</b>	<p>Following the successful online application, <b>Acceptance Letter</b> and <b>Visa/Residence Permit Letter</b> (if required) will be available for download in Mobility-Online.</p>
<b>Fields of Study</b>	<p>University of Graz is a public university with an enrolment of 31.100 students and a strong international profile offering more than 120 BA, MA and PhD degrees which are open to exchange students (except for a few restrictions – see below). <a href="http://studien.uni-graz.at/en/degree-programmes/">http://studien.uni-graz.at/en/degree-programmes/</a></p> <p><b>Focus:</b> The university's regional focus on South-Eastern Europe is one of the defining factors throughout all areas of study.</p> <p><b>Co-enrollment:</b> A unique cooperation with the Technical University of Graz (TUG) as well as Kunstuniversität Graz (KUG) allows students to co-enroll at TUG and/or KUG at no extra cost (TUG and KUG transcripts available). A min of 50 % of ECTS during the exchange must be taken at University of Graz.</p>

<b>Restrictions</b>	<p><b>Lab placements</b> are generally difficult and cannot be guaranteed.</p> <p><b>Joint Degree Programs</b> are only open to exchange students enrolled in one of these programs already at their home university (= partner in the Joint Degree program).</p> <p>An application for <b>translation/interpretation/transcultural communication with German</b> is only possible if students are enrolled in a translation/interpretation degree at their home university.</p>
<b>Early exams / Alternative exam modes</b>	<p><b>CANNOT BE GUARANTEED!! Each professor decides for his/her course whether early exams / alternative exam modes are possible. It is the student's responsibility to contact each professor as early as possible in the application process and definitely before finalizing travel plans in case they need to return to their home universities before the end of the exchange semester at Uni Graz.</b></p> <p>Early exams are <u>NOT available</u> for lecture-type courses at the Faculty of Business and of the field of English and American Studies. For other types of courses such as pro-seminars, seminars professors have the last say.</p>
<b>Housing</b>	<p><b>HENDRIX / HIGHPOINT STUDENTS:</b> housing will be arranged with non-recoverable costs covered by University of Graz. For details on the arrangement see housing overview.</p> <p><b>MONTCLAIR GRANTEES of the "Overseas Neighbors Scholarship":</b> housing will be arranged by the City of Graz</p> <p><b>ALL OTHER STUDENTS:</b> will make their own housing arrangements. <b>Language Requirements</b>	<p>University of Graz recommends language level B2 in German in order to take full advantage of the mobility. Students who will only take courses in English must have B2 English knowledge.</p> <p>Students who will only take courses in English must check whether they can find enough English-taught courses to fulfill their home university's credit requirements.</p>
<b>Language courses</b>	<p>3-week German Intensive Language Courses (6 ECTS credits incl. in transcript) are offered <b>in September and February</b> before the start of the semester at a reduced fee. <b>Health &amp; Safety Policy</b>	<p><a href="#">COVID-19 measures at University of Graz</a> provides up to date information of COVID-19 regulations at Uni Graz as well as a contact for further questions.</p> <p><a href="#">COVID-19 info for international arrivals</a> provides up to date COVID-19 related entry requirements, information on quarantine, etc.</p> <p>The compulsory student union fee includes <b>liability and accident insurance</b>. (way to and from the university as well as on campus). This does, however not replace full health insurance coverage for the exchange stay.</p> <p>Safety facilities and trainings are provided in specific departments where applicable (e.g. labs).</p>
<b>Health Insurance</b>	<p><b>All EU/EEA students</b> need to bring their European health insurance card to Austria as it will be valid during their stay in Graz.</p> <p><b>All non-EU/EEA exchange students nominated for 2 semesters</b> are required by law to register for Austrian health insurance upon arrival (assistance and more information available during the mandatory WELCOME WEEK). This insurance will not cover the student's journey to Graz including medical evacuation and repatriation – the student has to make sure s/he purchases travel insurance accordingly.</p> <p><b>Non-EU/EEA exchange students nominated for 1 semester</b> are free to choose their insurance as long as this insurance is in accordance with the requirements for an Austrian visa application. For details students have to contact the Austrian embassy in their country of residence. The insurance must also cover their journey to Graz including medical evacuation and repatriation.</p>

Graz University has no facilities to help secure a job. Students should NOT rely on getting a job in Graz when budgeting their exchange!</p>
<b>Transcripts</b>	<p>University of Graz no longer issues paper transcripts. ## ECTS & Grading system

The student workload consists of the time required to complete all planned learning activities, i.e. contact hours (lectures, seminars etc.) and private study (preparation for exams, writing of paper, reading etc.): **1 ECTS credit = 25 hours.**

Each **semester** is comprised of **15 teaching weeks**, therefore a course indicated as a 1-hour course in the online system equals 15 contact hours, a 2-hour course equals 30 contact hrs etc. For exchange students we consider a range **between 24 to 30 ECTS per semester as a full-time study load.**

**Assessment:** The method of assessment varies between subjects. Details can be found in the online course description of each course. Students are permitted to resit exams on site during the timeframe of their enrollment according to the study law regulations (Studienrechtliche Bestimmungen). Students are not entitled to alternative exam dates or exam modes. The decision about any such arrangements lies with the relevant professor.
