This conference was aimed primarily at the CO:OP partners and community and addressed some of the strategic goals pursued in the project. International contributors from outside the CO:OP project provided further input and a larger contextualization.

This workshop was organized through DARIAH-CR as part of the "Humanities at Scale" project, aimed at scholars and staff at research and cultural heritage institutions. The audience was introduced to the European legal framework (copyright and privacy), as well as common licensing models for digital content. The draft version of the CO:OP legal recommendations was presented for the first time at this event.
