PHARMACY:

The registration period for the field of study Pharmacy begins on 10.02.2017.

The allocation of confirmed places is done by the institute after the end of the registration period (the basis of the ranking is the curriculum).

The time of your registration within the registration period is thus irrelevant!

LAW:

Registration period for the field of Law starts on 14/2/2017, staggered into study stages.

14/2/2017: Subjects 1st stage of diploma programme.

15/2/2017: Subjects 2nd stage of diploma programme.

16/2/2017: Courses of the third stage of studies in diploma programme, doctoral courses, free electives.

17/2/2017: External and Internal Accounting / Financing Introductory Economics and Legal Perspectives

The registration process is followed by thy system "first come - first served". After registration for a course you will get a waiting list number. This number indicates your chances to get a confirmed place, by comparing the max. participants of each course with your number. Is your number lower than the max. capacity you will receive an email with the confirmed place.
