This Data Protection Declaration is designed to inform you, as an applicant for the European Joint Master's Programme in English and American Studies, in accordance with Articles 12 and 13 of the General Data Protection Regulation (GDPR), on the purpose, legal basis, and your rights regarding the processing of personal data by the EAS Consortium.

### **Purpose, scope and legal basis of data processing:**

We process your personal data:

indicated in the online application and application documents for the European Joint Master's Programme in English and American Studies on the basis of

- your consent given in the online application for the European Joint Master's in English and American Studies.
- the legitimate interest of the EAS Consortium with regard to quality assurance as well as for public relations and statistical purposes.

### **Duration of storage:**

Your data will be stored as long as required by legal storage periods or until you withdraw consent. Withdrawing consent does not affect the legality of earlier processing.

Processing of your data and documents by the EAS Consortium is a necessary step in the evaluation and selection process for the programme. Therefore, not providing the relevant information or withdrawing consent for the processing of the data and documents will result in your application not being considered for the programme.

### **Transmission of your personal data:**

Your data will only be processed within the EAS Consortium (University of Graz, University of Bamberg, Ca' Foscari University of Venice, University of Paris Diderot, University of Pécs, The City College of New York, Jagiellonian University in Kraków and Universitat Autònoma de Barcelona) as necessary to effect the above-mentioned purposes.



In case of an additional mobility at any other Higher Education Institution, your data will also be transmitted to the respective mobility university.

**Your rights:**

- the right of access to the personal data in question (Article 15, GDPR),

- the right to withdraw consent (Article 7(3), GDPR), which shall not affect the lawfulness of processing based on consent before its withdrawal,
