### **Maik Schneider**

Maik T. Schneider accepts the call to the Joseph A. Schumpeter Professorship for Public Economics at the University of Graz. Maik's main research interest is in the field of Public Economics, which he also combines with the field of innovation and economic growth. Furthermore, he has a research focus in the area of political economy. Maik's research addresses key challenges for the future, such as the economic impact of artificial intelligence, on which he recently completed a research project funded by the Leverhulme Trust. His research is regularly published in leading international journals, such as the Economic Journal, the Journal of Monetary Economics, Games and Economic Behavior, the Journal of Economic Growth and the European Economic Review. Maik has a strong international network and is the co-founder and

> organiser of the annual workshop series "Political Economy: Theory meets Empirics", which has been bringing together leading international researchers in the field of political economy to discuss the latest research for nine years already. Maik studied Industrial Engineering at the Karlsruhe Institute of Technology (KIT) and obtained his PhD in economics at the Ruprecht-Karls University of Heidelberg with a scholarship from the German Research Foundation (DFG). He then held an assistant professorship at ETH Zurich and was a visiting scholar at Stanford University. Later in his academic career, Maik held a professorship of economic policy at the University of Bath, UK, before following the call to the Joseph A. Schumpeter Professorship for Public Economics at the University of Graz at the beginning of the winter semester 2023-24.

### Viktoria Rohrer

Viktoria Rohrer successfully passed her PhD viva on March 29. She wrote her dissertation on the "Strategic Dimensions of Mitigationadaptation Games: Timing and Heterogeneity". Viktoria received for her dissertation and for her viva the highest possible mark (excellent). She received two external reports by Professor Jean-Francois Jacques (University Gustave Eiffel, Paris, France) and Professor Alejandro Caparros (University of Durham, Durham, UK) and was examined by Professor Jean-Francois Jacques in her viva. Her first supervisor was Michael Finus.




#### **Ebony Granada**

#### Standort Graz

This serves to pass on science-based observations with regard to regional and urban economic development trends in order to secure the locational

Online Workshop: "Modelling the Covid-19 Pandemic"

The team of the FWF project "Agent-based economic epidemiology" hosted a successful online workshop about the topic "Modelling the Covid-19 Pandemic" on November 23-24, 2022, via WebEx. Presentations were given by external speakers from the WHO, Imperial College, UCL and University of Tokyo, among others, as well as by the project team: Patrick Mellacher talked about modelling the economic and health impact of global vaccine inequality. Simon Plakolb reported about his efforts in creating a model that is able to capture viral evolution in a parsimonious hybrid agent- and equation-based model. Finally, Magdalena Rath gave a presentation about modelling the

short- and long-term effects of the Covid-19 lockdowns on gender inequality.

## **Environmental Sustainability and Protection Forum**

In the aftermath of the conference "Environmental Protection and Sustainability Forum" held in Graz in September 2022, organized by Stefan Borsky, Michael Finus, Birgit Bednar-Friedl and Karl Steininger, a special issue is launched on "Transboundary and Global Environmental and Resource Problems" in the Journal of Environmental Economics and Management. The deadline for submitting papers is May 31, 2023.



### Vienna-Graz-Workshop on Computational Social Choice, March 6-7, 2023

In March the first of an intended series of annual Vienna-Graz-Workshops in Computational Social Choice took place in Graz. The organizers Christian Klamler and Stefan Woltran (Technical University of Vienna), together with the local organizers Andreas Darmann and Daniel Eckert, brought together researchers from Graz and Vienna to discuss with various international guests the

application of normative criteria from economics to the new field of social epistemology in general and epistemic democracy in particular. Among the invited international guests were researchers from the University of Amsterdam such as Davide Grossi and Adrian Haret with papers on "Condorcet Markets", resp. "Deliberation as Evidence Disclosure", and Zoi Terzopoulou from the recently founded Groupe d'Analyse et de Théorie Economique Lyon-Saint-Etienne with a talk on "Managing and Aggregating Group Evidence under Quality and Quantity Trade-offs". In very fruitful discussions of the various presentations, the understanding of the surprisingly close connections between the approaches from social choice theory and those from computer science to the exploration of the normative aspects of collective decision making have been deepened and planted the seeds for further cooperation.
