## **DART-Accounting Workshop 2024**

On January 11 and 12, CAR hosted the annual DART workshop at the University of Graz. The workshop was organized by CAR's Rainer Niemann and featured participants from the University of Vienna, the University of Frankfurt, and the University of Mannheim. DART students Viktoria Kern, Klaus Haider, Bettina Mandl, Lisa Walcher, and Stefanie Pendl (Institute of Accounting and Taxation) presented their recent research. DART students Emmanuel Lederer, Kerstin Trummer, and Lisa Walcher as well as CAR's Martin Klösch and Theresa Wittreich, and Bernhard Haberl (Institute of Accounting and Reporting), Thomas

Kourouxous (Institute of Accounting and Taxation), and Benedikt Sieghartsleitner (Institute of Accounting and Auditing) discussed papers by PhD students from Vienna, Frankfurt, and Mannheim. The papers presented covered analytical and archival empirical research methods and addressed topics such as voluntary disclosure, auditing, taxation, managerial overconfidence, and ESG disclosures. The discussants and participants at the workshop provided many valuable suggestions and comments on how to improve the working papers, highlighting the papers' strengths as well as identifying critical points and offering ways forward during the workshop sessions and subsequent discussions. The lunches, coffee breaks, and dinner on the first evening provided an informal atmosphere for the DART students to expand their academic and social network.

## Wagenhofer elected as AFRAC Vice Chairman

At the plenary meeting on September 13th, 2023, the Austrian Financial Reporting Adivisory Committee (AFRAC) elected CAR's Alfred Wagenhofer as new Vice Chairman. He succeeds Prof. Christian Nowotny, who had been a member of the AFRAC Executive Committee since its foundation.

#### Schneider reelected to EAA Board

CAR's Georg Schneider has been reelected to the Board of the European Accounting Assiciation (EAA) as the National Representative for Austria. The term of office is three years (2024-2027) and will commence after the General Assembly of the EAA Congress 2024. Until 2025, Georg Schneider is also a part of the Standing Scientific Committee, advising the scientific programme of the Annual Congress.

## **CAR improves in BYU Accounting Ranking**

In February, Brigham Young University (BYU) published its annual update of the Accounting Ranking. In the ranking for 2023, the University of Graz has been ranked 9th in the citation-based ranking for analytical accounting research in the last 6 years. With 263 citations, the University of Graz continues to be the highest-ranked university in Europe in this field and second-highest non-US university, improving its standing from the 12th rank in 2022. In the ranking over "all years", the University of Graz ranks 11th (13th in 2022), with CAR's Ralf Ewert, Rainer Niemann, Georg Schneider, and Alfred Wagenhofer as the main contributors for the placement. It should be noted that the BYU ranking is somewhat US-centric in its coverage of top accounting journals.

# "Internal Performance Measures and Earnings Management" (TAR)



In this paper, published in The Accounting Review in January 2024, CAR's Alfred Wagenhofer and David Windisch together with Christian Gross (former PhD student at the Institute of Accounting and Control, now Kelag AG) examine whether the design firm's of a

management accounting system is associated with GAAP earnings management. They exploit the fact that ASC 280 mandates "management approach" multisegment firms to disclose their segment earnings as defined internally by their management accounting system. They posit that the more aligned segment earnings are with

GAAP earnings, the higher are the costs of earnings management because earnings management of GAAP earnings spills over to segment earnings and distorts information used for internal decision-making. They predict that firms with more decoupled segment earnings engage in more earnings management. Using a large sample of U.S. firms from 1998 to 2020, they find support for this prediction. They also find that the decision usefulness of segment earnings for segment investment purposes decreases as earnings management increases, where this association is more pronounced for firms with less decoupled segment earnings measures.

## Niemann receives Golden Ring of Honor of the University of Graz

On February 5th, CAR's Rainer Nieman received the Golden Ring of Honor of the University of Graz. The University can award this ring to particulary deserving representatives of public life or science. This is the university's highest award and recognizes Niemann's ten years of service as Chairman of the Senate. He particularly oversaw two rector elections and led the Senate during the difficult times of the COVID-19 pandemic.
